GETTING STARTED: 2 - 4 WEEK INITIAL PROCESS

FREQUENTLY ASKED QUESTIONS

HOW MUCH DOES THIS PROGRAM COST?

The Patient Assistance Program (PAP) is provided to you completely free of charge from your employer.

I HAVE INSURANCE; WILL THIS SAVE ME MONEY?

Yes! If you qualify for the program, your medication will be provided completely free of charge (e.g. no future copays or deductibles)

HOW DO YOU WORK WITH MY PRESCRIPTION INSURANCE?

We work hand-in-hand with your prescription insurance. We will ensure that at no point will you ever miss a prescription.

HOW LONG DOES THIS PROCESS TAKE?

We can help a member enroll in less than 30 minutes. Once the application is submitted, the process usually takes about 2 to 4 weeks.

WHAT IS A PATIENT ASSISTANCE PROGRAM?

Patient Assistance Programs support U.S. residents with free medications based on financial need. The programs usually cover brand name drugs and are administered individually by the pharmaceutical manufacturer of the drug or a compassionate member foundation.
